A Message From Our President

I am happy to present to you the Annual Report for the Charlottesville-Albemarle Rescue Squad. Our rescue squad has been in continuous existence for more than sixty years, since we were formed in 1960. We continue to answer calls for assistance and look forward to continuing to serve our community in the future!

Things have certainly changed since our early years. We are now dispatched by a modern 911 center instead of a local lawyer's secretary. Training requirements have increased. We can do more things to help a patient on scene and have better communications with the local hospitals. We are no longer the only rescue squad in town, instead working with the volunteers of Western Albemarle Rescue Squad and some County fire stations and the paid providers of the City of Charlottesville Fire Department and Albemarle County Fire Rescue.

However, some things haven't changed. All of our providers are still volunteers. While we have hired a full-time Executive Director and are very pleased we have someone who can do some of the needed work full-time, the majority of our operations are



still handled by dedicated volunteers who provide their time and knowledge to our community.

As we look to the future, we are working on upgrading our equipment and especially our ambulances, which have seen a lot of use. In addition, we are looking to revamp our station, which is the oldest in the City and County and has not changed much since the mid-1960s. Most of all, we are looking to continue to do our part in a regional high-performing EMS system.

The Value of 145 Volunteers



In FY 21, CARS volunteers ran **5,988 calls** - **72% of the City's EMS calls and 21% of the County's calls**. This equates to over **80,000 hours of service** and **\$3.4 million** is cost saving to our citizens. Additionally our volunteers served at 28 medical standby events.

Becoming a Life Member of CARS is a huge commitment and is not

something most volunteers achieve. It requires 8 years (more than 5,000 hours) of service.. In October, we welcomed our newest Life Member, Michael Chilmaid to this elite group.

Michael is a native of England and first joined the Charlottesville-Albemarle Rescue Squad in 2009, as a newly trained EMT while attending UVA. In 2011, he completed his Trauma level class and went on to become a medic in the Spring of 2013, shortly before graduating with his degree in psychology.

Michael remained involved with CARS while getting his master's degree in Healthcare Administration from University of North Carolina at Chapel Hill. Shortly after graduating in 2018, Michael accepted a position at Emory HealthCare in Atlanta. The 500 mile distance didn't deter Michael's commitment to CARS. He commuted to Charlottesville so he could run shifts on weekends. He stayed with friends in Charlottesville or family in Richmond and occasionally stayed in a hotel. When asked why he made this sacrifice, Michael replied, "I missed providing patient care and the people at CARS." The EMS system in Atlanta is career based so it did not offer opportunities for Michael to get involved.

Michael returned to Charlottesville in 2019, when he accepted a job at UVA Health as a Quality &

Performance Improvement Coach. In this role, he works with various teams across the UVA Medical Center to improve clinical quality, operational efficiency, and staff engagement.

Michael has served in various roles with the agency and is currently an active Medic and Shift Supervisor and is a member of the Board of Directors. Beyond CARS, Michael's EMS experience includes work with the UVA Special Event Medical Management team. In his free time, he enjoys traveling, running, and is a big soccer fan.
